If you have earned pension benefits in more than one section or arrangement of the Railways Pension Scheme the Trustee Company will consider the nominations detailed on this form in respect of each section or arrangement in the Scheme.

Your pension scheme provides death benefit cover if you die.

Any benefits will be paid by the Trustee Company in accordance with the rules for your section or arrangement in the scheme. If you die, the Trustee Company will gather information relating to your dependants to help it to decide who should receive any lump-sum death benefit.

To help the Trustee Company make its decision, you can record your wishes by filling in this form and sending it to rpm.

The Trustee Company does not have to follow your wishes, but it will consider them and look at your personal circumstances at the time of your death. It will then decide who will receive the benefits.

If your personal circumstances change after you have filled in this form, you can change your nominations simply by filling in another form and sending it to rpm to replace any previous nominations you have made. You will find their address on the back of this form.
